FORWARD

The Arkansas-Oklahoma State Fair is sponsored by the Arkansas-Oklahoma Regional Education and Promotion Association, Inc. exclusively for the purpose of instructing and educating the residents of Arkansas and Oklahoma on agricultural matters by conducting annual public fairs and exhibitions, including but not limited to informing the public in general and farmers in particular about the resources of the region and the methods by which they may be conserved, utilized and improved as well as the newest and best techniques of farming.

The State of Arkansas has designated this Fair as the official district livestock show for the Second Agriculture District consisting of the following counties in Arkansas: Benton, Conway, Crawford, Franklin, Johnson, Logan, Perry, Polk, Pope, Scott, Sebastian, Washington, and Yell. In addition, the Arkansas-Oklahoma State Fair accepts junior exhibits from the following 12 counties in Oklahoma: Adair, Cherokee, Delaware, Haskell, Latimer, LeFlore, McCurtain, McIntosh, Muskogee, Pittsburg, Sequoyah, and Wagoner. **Junior exhibitors are not allowed to show at this Fair beyond the fall semester following graduation.**

**DOGS ARE PROHIBITED ON THE FAIRGROUNDS!
ONLY SERVICE ANIMALS ALLOWED!**

Exhibitors' General Rules and Regulations

EXHIBITOR ENTRY STATEMENT

Exhibitor Entry Statement is automatic when registering online.

RULE 1. Online entries deadline is Friday, September 4th at 4pm.

**WHEN REGISTERING ONLINE PRINT CONFIRMATION PAGE, BRING AT CHECK-IN.
ABSOLUTELY NO ENTRY WILL BE ACCEPTED AFTER DEADLINE!**

NOTE: Class substitutions on existing entries may be made at a cost of 1/2 plus the regular entry fee. Substitutions may be made only in the same breed. This must be handled at the EXPO OFFICE - prior to check-in of animals.

NO REFUND WILL BE MADE AFTER ENTRIES CLOSE.

NO PENDING REGISTRATION PAPERS WILL BE ACCEPTED ON ANIMALS OLDER THAN JAN. 1, 2026.

The management reserves the right to remove from the grounds any exhibit or animal that may be falsely entered, or may be deemed unsuitable or objectionable, without assigning a reason therefore, and, if necessary, to return any money already paid for space or stalls which shall exonerate the Show from any claims whatsoever on the part of the exhibitor.

RULE 2. All animals must be in place on the show grounds as designated in each division and must remain on exhibition on the grounds until released by the superintendent. A stall assignment diagram may be found in each barn. Stall space will be assigned by the appropriate superintendent. Exhibitors are asked to check this assignment chart before bedding down any animals. **[Shavings only for bedding by ruling of fire marshal. Except for dairy cattle and breeding sheep.]**

CARE OF ANIMALS

You can bring tack Thursday, September 24, from 5 p.m. to 8 p.m.

RULE 3. All owners of livestock, or others having same in charge, shall care for, guard, protect and preserve the same, as the Arkansas -Oklahoma State Fair does not undertake to do so, and it shall not be held responsible for any loss or damage to said property or the owners thereof.

RULE 4. Each Livestock exhibitor must furnish his own bucket for watering, and his own feed troughs, except for poultry, which will be furnished by the Fair.

RULE 5. Attendants: All attendants in charge of livestock shall be competent, courteous, and neatly dressed, and shall impart to visitors such information as may be desired. BLANKETS MUST BE REMOVED AND STOCK KEPT IN CONDITION FOR INSPECTION BY THE PUBLIC FROM 10 A.M. TO 10 P.M. TIE OUT TIME WILL BE 10 P.M. DAILY. If tie out spaces are desired, designate number of animals on online entry to be tied out.

CARE OF STALLS AND PENS

RULE 6. All stalls, pens and exhibition places must be cleaned before 8:00 A.M. each day and refuse matter disposed of in the dumpsters provided. EACH EXHIBITOR IS EXPECTED TO KEEP HIS STALLS, PENS, AND/OR EXHIBITS CLEAN, NEAT AND WITH FRESH BEDDING. NO ROUND BALES OF STRAW OR HAY ALLOWED ON FAIRGROUNDS. FOR THOSE EXHIBITORS REFUSING TO COMPLY, THE MANAGEMENT RESERVES THE RIGHT TO HAVE SAID STALLS OR PENS PROPERLY CLEANED WITH THE COST TO BE CHARGED AGAINST THE EXHIBITOR.

ENTRY FEE CHARGES

RULE 7. The following fees will govern the 2026 Arkansas-Oklahoma State Fair and must be paid at time of registration.

Cattle: Open Division:

For each entry in individual classes.....\$30.00

Cattle: Junior Division:

For each entry in individual classes..... \$25.00

Sheep: Junior Divisions: Per animal\$20.00

Market Goats:.....\$20.00

Dairy Goats: Junior Divisions (includes open) \$25.00

Dairy Goats: Open.....\$20.00

Open Breeding Sheep:\$20.00

Swine: Per animal.....\$20.00

Poultry Open and Waterfowl: Per bird \$ 4.00

Poultry Junior Division: Per bird/sets\$ 4.00/\$5.00 per set

Rabbits: Per animal\$ 4.00

OWNERSHIP OF ANIMAL

RULE 8. To be eligible for competition in open or junior classes, whether singularly or in groups, animals must be the bona fide property of the exhibitors, and all animals entered for competition, except where otherwise specified, must be entered in the name of the owner, and must have been owned by the owner not less than sixty days prior to the opening day of the fair. Registry certificates of ownership must be produced, showing the exhibitor to be the owner. In case of transfer of ownership, the date appearing on the transfer will indicate period of ownership. Animals composing a group must all be owned by the same individual, firm, partnership or recognized association, in which case associations will be considered as owners, unless otherwise stated in this premium list.

ELIGIBILITY OF ANIMALS

RULE 9. All animals in the breeding classes must be recorded or accepted for record in the recognized books of record for their respective breeds, and exhibitors must produce certificate of registry at the request of the superintendent in charge any time during the show. The exhibitor must give on his application for entry, the breed, date of birth, registration number and name under which the animal is registered in the record association. Otherwise, entry will not be accepted. This rule does not apply to animals entered in market classes. In this classification, age, tattoo, sex and name of breed of animal are requested on the entry application.

IAFE (INTERNATIONAL ASSOCIATION OF FAIRS AND EXPOSITIONS) SHOW RING CODE OF ETHICS

RULE 10. Exhibitors of animals at livestock shows shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured competition classes. This code applies to all livestock offered in any event at a livestock show. In addition to the "IAFE National Code of Show Ring Ethics," fairs and livestock show may have rules and regulations which they impose on the local, county, state, provincial and national levels.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada. The following is a list of guidelines for all exhibitors and all livestock in competitive events:

- 1) All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.
- 2) Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.

- 3) Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
- 4) Animals shall be presented to show events where they will enter the food chain free of drugs. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable Federal, State, and Provincial statutes, regulations, and rules. Livestock shall not be exhibited if the drugs administered in accordance with Federal, State, and Provincial statutes, regulations, and rules affect the animal's performance or appearance at the event.

If the laboratory report on the chemical analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the approved laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise at any hearing in regard to the matter conducted by the fair or livestock show.

At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian.

- 5) Any surgical procedure or injection of any foreign substance or page 15 or the external application of any substance (irritant, counter irritant, or similar substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
- 6) The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
- 7) Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
- 8) No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individuals to disciplinary action.
- 9) The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.

- 10) The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have any disciplinary action taken by the fair or livestock show for violation of this code of show ring ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including *Fairs and Expositions* and any special notices to members.
- 11) The act of entering of an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the IAFE National Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

EXHIBITION HERDS AND NEW BREED SECTION

RULE 11. The requirement for starting a new Official Breed Show is a minimum of twenty-five head of acceptable quality on exhibit by at least three exhibitors for two consecutive years as an exhibition herd, after which, they would then be eligible for an Official Breed Show and premium money would be provided. The management must be petitioned following the second year of exhibition and furnished a list of exhibitors and cattle to establish eligibility for an Official Breed Show the following year. Minimum of 3 exhibitors must exhibit a minimum of 20 animals to maintain breed show. Stall fees for exhibition herds are the same as for other cattle in the Open Department. This rule does not apply to the Junior Department. A minimum of ten head which satisfy all of the same requirements will establish eligibility for the Sheep Division.

JUDGES' RULES

RULE 12. Interference with Judges: Any attempt by an exhibitor either personally or through an agent, to corrupt the judges or exert undue influence will subject the offender to expulsion from the grounds, and he will thereafter be prohibited from exhibition or other privileges until restored by order of the Manager.

RULE 13. Method of Awarding: No animal shall be awarded a prize unless exhibited before the judge in the show ring at the time specified. Exhibitors should ascertain from the various Superintendents of Departments at what time the exhibits under their charge will be judged. Decisions of the judge will be final.

PROTEST AND APPEAL

RULE 14. All protests from a decision of a judge must be made to the Manager of the Fair within five hours after the award is made; it being considered an award is made when the notation of the decision of the judge is entered in the Department Entry Book.

RULE 15. In every case of protest, whether against the exhibition of the animal or against an award, the protesting party must deposit with the Manager the sum of \$195.00. Should the protest be sustained, the deposit shall be returned to the protesting party; otherwise, it will be forfeited.

RULE 16.. In addition to the right to protest herein granted to the exhibitor, the Arkansas-Oklahoma State Fair reserves the right to take cognizance of fraud consummated or

attempted in connection with an exhibit and take such action as may be deemed just and proper, and as may be warranted in these premises.

RULE 17. No protest or appeal based upon the statement that the judge or judges are incompetent or have overlooked an animal will be considered by the management.

RULE 18. Decisions of awarding judges shall be final, and no appeal will be considered except as herein provided.

RULE 19. All questions in dispute or difference not covered by these rules will be referred to the Management, whose decision shall be final.

RULE 20. Where there are fewer animals shown in classes than number of premiums offered, the judges will award a prize or prizes of such grade as the animal deserves.

RULE 21. WHERE THERE IS NO COMPETITION OR ONLY ONE EXHIBIT IS ENTERED, EXHIBITS WILL BE AWARDED FIRST, SECOND OR THIRD PRIZE OR NO PREMIUM ACCORDING TO THE MERIT OF THE EXHIBIT. THIS RULE APPLIES TO ALL LIVESTOCK, POULTRY AND HORTICULTURAL EXHIBITS.

RULE 22. Premiums will be paid strictly upon the report as shown in the Award book. This record shall stand as official.

DEPARTMENT SUPERINTENDENTS

RULE 23. Superintendents shall see that each exhibitor has paid all stall rent or other charges, as evidenced by receipt from Manager, before judges are permitted to pass on the exhibit.

RULE 24. The Superintendent will direct the arrangement of all animals on exhibit in his department. He shall give such instructions to the rewarding judges or committee as will result in judicious action and decide all questions which may be presented in accordance with the regulations governing the Department and shall allow no one except judges in the show ring when exhibits are being judged.

RULE 25. Each Superintendent is charged with caring for and returning the entry book of his department, with the awards for each exhibit duly and properly entered therein and each award signed by himself and the Judges who made the award, as premiums cannot be paid unless this is done.

RULE 26. Superintendents must check on the exhibits competing for premiums in each class and so mark the entry book that it will show what animals were exhibited in each class, as well as which were awarded premiums. Entry books must give names and registry numbers of all animals, as premiums cannot be paid unless this is done.

RULE 27. After all entries are made, the Superintendent will have charge of the Entry Book; the Judges must not have access to this book until after awards are made in each class, when it is presented to him by the Superintendent for his signature. The Judge should verify the entry numbers receiving the award before affixing his signature.

RULE 28. Superintendents shall see that exhibitors keep space allotted them in a neat and clean condition and that stalls containing livestock, and the approaches and walks are kept clean.

FEED DELIVERY AND BEDDING

RULE 29. Feed and hay may be delivered on the show grounds by anyone who has an order for same from a livestock exhibitor. Feed deliveries must be made before noon each day; however, when absolutely necessary the Department Superintendent may at his discretion authorize feed deliveries at other times. Feed for poultry exhibits will be furnished free of charge by the Arkansas-Oklahoma State Fair.

RULE 30. Shavings will be available to all exhibitors for a fee. Straw bedding will be allowed for dairy cattle and breeding sheep only. **[FIRE MARSHAL RULING: SHAVINGS ONLY FOR ALL OTHER LIVESTOCK BEDDING.]**

EXHIBITION HEALTH REQUIREMENTS FOR LIVESTOCK, POULTRY AND EXOTIC ANIMALS

RULE 31. General Requirements:

- 1) **CERTIFICATES OF VETERINARY INSPECTION AND ENTRY PERMITS:** “Certificate of veterinary inspection” refers to a legible record (made on an official form issued from the state of origin) by an accredited veterinarian, which shows that the animals listed thereon meet health requirements of the state of destination. It must bear the identification of each animal and separate certificates must be made for each species of animal entered. Entry permits are required on all out-of-state swine, rodeo bulls, passerines, ratites, all other avian species except poultry and turkeys, camelids, or exotic animals. Permits are also required on all cattle entering Arkansas from any state that is not Tuberculosis free state, unless that state has reciprocal agreement with Arkansas. Permit numbers can be obtained from the state veterinarian’s office (501) 907-2400 from 8:00 a.m. to 4:30 p.m. Monday through Friday. A certificate of veterinary inspection must accompany all out-of-state animals; and
 - a) Must be available on request by animal health officials.
 - b) Individually identify all animals, showing positive identification of each animal by tattoo, ear tag, registration number or ear notch. Steers should be identified by description.
 - c) Show required tests, vaccinations, and entry permit number, if applicable.
 - d) Show name and address of owner or exhibitor – this shall be the same name as under which animals are exhibited.
- 2) Any animal or poultry showing any evidence of infectious or contagious disease, or of external parasitism, and animals with active ringworm lesions (with the resulting loss of hair), multiple warts easily visible without close examination, or atrophic rhinitis, will not be permitted to exhibit.
- 3) All animals entering the grounds, including those shown in pet zoos, children’s barnyard animals, Old McDonalds Farm, etc. must meet requirements of their particular species.
- 4) All animals originating out of areas quarantined because of other diseases (vesicular stomatitis, scabies, etc.) shall not be permitted to enter the state.

OUT-OF-STATE CATTLE

- 1) Valid certificates of veterinary inspections.

2) Brucellosis Requirements:

Heifers that were born on or after January 1, 1985, that are over twelve (12) months of age and are not official calfhood vaccinations will not be allowed to show unless they are from a Brucellosis Certified Free Herd or a Class Free state. All females and bulls eighteen (18) months of age and over must have a negative brucellosis test conducted at a state or federal laboratory within thirty (30) days prior to the exhibition. Those exempt from testing requirements, as follows:

- a) Animals originating out of Class Free states.
- b) Animals originating out of Certified Free Herds provided that the Certified Free herd number and test date is recorded on the certificate of veterinary inspection. Rodeo bulls participating in a recognized and organized performance group may enter with a negative test for brucellosis within twelve (12) months if they are individually identified and accompanied by an entry permit regardless of state or area status.

1. Tuberculosis Requirements:

All sexually intact dairy cattle six months of age and older for interstate entry into Arkansas will be required to have a negative tuberculosis (TB) test within sixty (60) days prior to entry.

1. These same dairy cattle will also be required to have an entry permit and a certificate of veterinary inspection prior to entry, as well as the negative test and must be officially identified.
2. Sexually intact dairy cattle under six months of age can be permitted under a hold order direct to a premise or designated facility and held there until they are tested negative at six months of age, at owner's expense.
3. The new regulation exempts dairy cattle that originate from accredited free TB herds (but not free states). Neutered dairy feeder cattle, and dairy cattle delivered direct to slaughter, or delivered to a market for sale direct to slaughter.
2. **Rodeo Stock:**
 1. All rodeo bulls twelve (12) months of age and older must have a tuberculosis test annually (12 months) before entering Arkansas for a rodeo. This requirement applies to all rodeo bulls regardless of their origin state or area status, and even rodeo bulls from Arkansas. All bulls must be individually identified with some type of USDA official ID. Out-of-state rodeo bulls are required to have a thirty (30) day CVI and an entry permit.
 2. All roping and dogging steers and heifers must have an annual tuberculosis test (every 12 months) before entry into AR for a rodeo. This requirement applies to all steers and heifers regardless of the origin, state or area status, and even steers and heifers from Arkansas. All steers and heifers must be individually identified with some type of USDA official ID. All tie down and roping calves are exempt from this regulation. In addition, M branded (Mexican) steers and heifers must have two negative annual tests for TB or one negative yearly test plus a sixty (60) day negative TB test. Out of state steers and heifers are required to have a thirty (30) day CVI and an entry permit.
- 3) All breeding beef cattle 12 months of age and older entering Arkansas must meet one (1) of the following requirements:
 - a) Originate from a tuberculosis-free state;
 - b) Originate from a tuberculosis-free herd. The herd number and current herd test date must be shown on the Certificate of Veterinary Inspection;
 - c) Test negative within sixty (60) days of shipment;
 - (1) These same beef cattle will also be required to have a certificate of veterinary inspection and will be required to have a permit if entering from a state that has lost its tuberculosis-free status.
 - d) Originate from a state having a reciprocal agreement with Arkansas;
 - e) All sexually intact cattle and bison, from any foreign country or part thereof with no recognized tuberculosis status comparable to the Uniform Methods and Rules standards of the U.S. Bovine Tuberculosis Eradication Program, imported for reasons other than immediate slaughter or feeding for slaughter must meet the following criteria:
 1. Obtain a permit issued by the Arkansas Livestock and Poultry Commission prior to entry; and
 2. Be quarantined to the Arkansas premises approved in the entry permit pending two (2) consecutive negative tuberculosis tests. The first test to be conducted not less than ninety (90) nor more than one hundred twenty (120) days after arrival and the second test to be not less than two hundred ten (210) days nor more than two hundred forty (240) days after arrival in Arkansas; or
 - f) Importation of steers and spayed heifers from Mexico,
 1. Steers and spayed heifers from Mexican states that have been determined by the

State Veterinarian of Arkansas, based on the recommendations of the Bi-National Committee, to have fully implemented the Control/Preparatory Phase of the Mexican Tuberculosis Eradication Program may enter Arkansas provided they have been tested negative for tuberculosis in accordance with the Norma Oficial Mexicana (NOM) within sixty (60) days prior to entry into the United States and obtain an entry permit prior to entering Arkansas.

2. Steers and spayed heifers from Mexican states that have been determined by the State Veterinarian of Arkansas, based on the recommendations of the Bi-National Committee, to have fully implemented the Eradication Phase of the Mexican Tuberculosis Eradication Program by March 1, 1997, may enter Arkansas provided they have been tested negative for tuberculosis in accordance with the Norma Oficial Mexicana (NOM) within sixty (60) days prior to entry into the United States. Steers and Spayed heifers from herds equal to U.S. Accredited TB-Free herds may enter Arkansas without testing provided they are moved directly from the herd of origin across the border as a single group and not commingled with other cattle prior to entering Arkansas.
 3. Steers and spayed heifers from Mexican states that have been determined by the state Veterinarian of Arkansas, based on the recommendations of the Bi-National Committee, to have achieved Accredited Free status may enter Arkansas without resting provided they are moved as a single group and not commingled with cattle of a different status prior to arriving at the border and obtain an entry permit prior to entering Arkansas. No sexually intact rodeo stock from Mexico will be permitted into Arkansas.
 4. Holstein and Holstein-cross steers and spayed heifers from Mexico are prohibited from entering Arkansas regardless of test history.
 5. Rodeo stock from Mexico must be tested negative for tuberculosis within sixty (60) days prior to their utilization as rodeo or roping stock under supervision of a USDA/APHIS port veterinarian or a U.S. accredited veterinarian, retested for tuberculosis every twelve (12) months thereafter, and obtain an entry permit prior to entering Arkansas. No sexually intact rodeo stock from Mexico will be permitted into Arkansas.
 6. Rodeo stock from any state that has lost its tuberculosis (TB) accreditation must be tested negative for tuberculosis within sixty (60) days prior to their utilization as rodeo or roping stock and retested for tuberculosis every twelve (12) months thereafter.
- 4) The State Veterinarian may designate high incidence areas within certain states that must meet additional import restrictions and retest requirements.

OUT-OF-STATE SWINE

1. As of July 1, 2001, an official premise identification and individual identification.
2. Valid certificate of veterinary inspection
3. Permit Number
4. **Brucellosis requirements:**

Negative brucellosis test on all intact males (i.e., barrows excluded) and females six (6) months of age and older, within thirty (30) days prior to the exhibition. Animals originating directly out of Validated Brucellosis Free Herds, with the Validated Free Herd number and date of last test on the certificate, and animals from Swine Brucellosis Free State are exempt from testing requirements.

5. Pseudorabies Requirements:

A negative pseudorabies test, regardless of age, within thirty (30) days prior to exhibition. Animals originating out of Pseudorabies Qualified Herds, with the Qualified Herd number on the certificate, and animals from Pseudorabies Free states are exempt from testing.

OUT-OF-STATE SHEEP AND GOATS

All sheep and goats entering Arkansas for exhibitions shall meet all requirements for entry into Arkansas. All sheep and goats imported or exhibited within the state of Arkansas must be identified by an official USDA tag (scrapie tag) or for goats a legible official goat registry tattoo if accompanied by a registration certificate.

All sheep and goats exhibited within Arkansas must have a certificate of veterinary inspection within thirty (30) days of exhibition.

Exhibition officials must maintain records of all sheep and goats that are exhibited for a period of five years, to include:

- a. Identification Number
- b. Flock Status as defined by the Voluntary Flock Certification Program
- c. The name, complete address and phone number of the owner.

Fair personnel, veterinarians, or state-federal personnel may examine sheep on grounds. Any sheep showing clinical symptoms of Scrapie shall be immediately quarantined in isolation and required to undergo any approved diagnostic tests and shall be consigned to slaughter or destruction with submission of tissues to an approved diagnostic laboratory at the exhibitor's expense.

Commingle (as defined by the Arkansas Scrapie Regulation) of sheep or goats of different flock status as defined by the Voluntary Flock Certification Program (VFCP) is prohibited and must be reported to the VFCP state official and State Veterinarian.

No sheep or goats showing symptoms of disease, particularly foot rot, sore mouth, sheep pox, evidence of fungal infection, evidence of abscesses or with draining abscesses will be allowed to show and may be released by fair officials, veterinarians, or state-federal personnel.

OUT-OF-STATE HORSES

1. Valid certificate of veterinary inspection with individual identification and a rectal temperature reading on each animal.
2. A negative EIA test must have been conducted on all Equidae over six (6) months of age within twelve (12) months prior to the exhibition, and the EIA test papers must accompany the certificate. Nursing foals under six (6) months of age are exempt from testing if accompanied by negative tested dams. (Photocopies of the test papers will not be acceptable – legible carbon copies will be acceptable.)

OUT-OF-STATE RATITES

All ratites must have a negative test for avian influenza within thirty (30) days prior to entry and exhibition unless a state of emergency has been declared. They must be individually identified with a form of permanent identification and listed on a certificate of veterinary inspection with an entry permit number.

OUT-OF-STATE CERVIDS

The regulations for the importation of Cervids lie with the Arkansas Game & Fish Commission.

OUT-OF-STATE CAMELIDS

1. Individually identified, and valid certificate of veterinary inspection within thirty (30) days
2. Permit number.
3. Registration papers when accompanied by registry photographs of the animal are acceptable identification.

OUT-OF-STATE RABBITS

1. No certificate of veterinary inspection required. Inspection will be made on grounds. No rabbits showing symptoms of disease will be allowed to show.

OUT-OF-STATE POULTRY

1. All poultry, which includes game birds, quail, pheasants, peafowl, turkeys, and waterfowl shall have originated from a US Pullorum clean flock or have had a negative pullorum test within ninety (90) days of entry. All turkeys shall also have originated from a US MG clean flock or have had a negative MG test within thirty (30) days of entry. All the preceding information must be documented on a valid certificate of veterinary inspection, and NPIP flock certification form or similar certificate. These forms must indicate that the flocks from which eggs or chicks originated have been tested for pullorum disease and were free of reactors; or, any eggs or chicks or poults produced under the supervision of the National Poultry Improvement Plan will be deemed to have met with the requirements of these regulations, provided all of the requirements of NPIP are complied with and applicable NPIP forms accompany birds. All non-certified poultry must be individually identified, either by a permanent leg or wing band or tattoo. Wrap-around plastic bands are not acceptable. NPIP certified flocks of turkeys, chickens, and domesticated fowl entering on a VS 9-3 or NPIP flock certification form or similar certificate are exempt from the requirement of a certificate of veterinary inspection unless a state of emergency has been declared.

OTHER OUT-OF-STATE TAME OR EXOTIC ANIMALS

Please call State Veterinarian's office for information and permit.

ARKANSAS LIVESTOCK

COUNTY, JR. DISTRICT, DISTRICT, STATE FAIR LEVEL, AND OTHER SHOWS

1. All animals entering the grounds, including those showing in pet zoos, children's barnyard animals, Animal Petting Zoo, etc. must meet the requirements of their particular species.
2. Arkansas livestock (except for Arkansas sheep, goats, horses, steers and rabbits) must be accompanied by a certificate of veterinary inspection issued within 90 days prior to exhibition, showing the following:

ARKANSAS CATTLE

1. If Arkansas is a Class Free State, Arkansas cattle are exempt from brucellosis testing. If Arkansas is not a Class Free State, then the following testing requirements must be met: Negative brucellosis test within ninety (90) days prior to exhibition, for females and bulls eighteen (18) months of age and over. All heifers that have calved or are bred must be tested. Animals originating from a Certified Brucellosis Free Herd are exempt if the Certified Free Herd number is shown on certificate.
2. All heifers that are 4-12 months of age shall be vaccinated before entering show.
3. Heifers that were born on or after January 1, 1985, that are over 12 months of age and are not official calfhooed vaccinates will not be allowed to show (unless they are from a Brucellosis Certified Free Herd.) This will not apply if Arkansas continues as a Brucellosis Free State.

4. All rodeo stock exhibited at a rodeo in Arkansas must meet the out of state requirements for brucellosis and tuberculosis for twelve (12) months and older bulls, roping and dogging steers, and heifers even if the rodeo stock originates from Arkansas. Tie down roping calves are exempt from the tuberculosis testing requirements. The exception is a CVI within the state is good for ninety (90) days instead of thirty (30) days.

ARKANSAS SWINE

1. As of July 1, 2001, all swine must have an official premise identification.
2. Animals six (6) months old or older to be tested negative for brucellosis within ninety (90) days of exhibition or originate directly out of a Validated Herd, with Validation number and date of last herd test shown on certificate (barrows exempt from brucellosis testing but must be pseudorabies tested.)
3. Animals to be tested negative for pseudorabies regardless of age within ninety (90) days of the exhibition on a test approved by the state veterinarian or originate out of a Qualified Pseudorabies Free Herd, with Qualified Herd number and date of last test shown on certificate.
4. Free of other contagious, infectious, and communicable diseases (erysipelas, atrophic rhinitis, etc.); otherwise, they will not be allowed to show and will be released from fairgrounds.

ARKANSAS SHEEP AND GOATS

Exhibition officials must maintain records of all sheep and goats that are exhibited for a period of five years, to include:

- a) Identification Number
- b) Flock Status as defined by the Voluntary Flock Certification Program
- c) The name, complete address and phone number of the owner.

All instate sheep and goats in the state of Arkansas must be identified by an official USDA tag (scrapie tag) or for goats a legible official goat registry tattoo if accompanied by a registration certificate.

Fair personnel, veterinarians, or state-federal personnel may examine sheep on grounds. Any sheep showing clinical symptoms of Scrapie shall be immediately quarantined in isolation and required to undergo any approved diagnostic tests and shall be consigned to slaughter or destruction with submission of tissues to an approved diagnostic laboratory at the exhibitor's expense.

Commingle (as defined by the Arkansas Scrapie Regulation) of sheep or goats of different flock status as defined by the Voluntary Flock Certification Program (VFCP) is prohibited and must be reported to the VFCP state official and State Veterinarian.

No sheep or goats showing symptoms of disease, particularly foot rot, sore mouth, sheep pox, evidence of fungal infection, evidence of abscesses or with draining abscesses will be allowed to show and may be released by fair officials, veterinarians, or state-federal personnel.

ARKANSAS RABBITS

Rabbits will be inspected on grounds. No rabbits showing symptoms of disease will be allowed to show.

ARKANSAS HORSES

Negative EIA test within twelve (12) months for all animals over six (6) months of age. Nursing foals under six (6) months of age are exempt from testing if accompanied by negative tested dams. Photocopies of the test papers will not be accepted; legible carbon are acceptable.

ARKANSAS CERVIDS

1. Certificate of veterinary inspection.
2. Negative cervical tuberculosis test within ninety (90) days.
3. Negative brucellosis test within ninety (90) days;

4. Or originate from a Certified Brucellosis-Free and Accredited Tuberculosis Free Cervid Herd;
5. Or originate from a Brucellosis-Monitored and a Qualified Tuberculosis Cervid Herd within ninety (90) days of exhibition.

ARKANSAS CAMELIDS

1. Individually identified, and certificate of veterinary inspection within ninety (90) days of exhibition.
2. Registration papers when accompanied by registry photographs of the animal are acceptable identification.

ARKANSAS RATITES

1. Certificate of veterinary inspection.
2. Negative avian influenza test within ninety (90) days.
3. Permanent identification.

ARKANSAS POULTRY

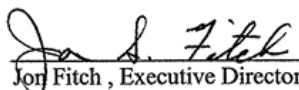
An official representing the exhibition shall notify the state veterinarian no later than thirty (30) days prior to the exhibition, giving names, place, inclusive dates, and time of the event.

The requirements for the exhibition are as follows:

- 1) All in-state poultry, which includes domesticated game birds, quail, pheasants, peafowl, guineas, and turkeys, present at exhibitions in Arkansas shall have originated from U.S. Pullorum-Typhoid Clean or equivalent flocks or have had a negative pullorum-typhoid test within ninety (90) days of the movement to the exhibition (pullorum-typhoid testing on fairgrounds during the fair is prohibited). This information will be documented on a NPIP Form VS 9-3, 90-Day Certificate, NPIP Flock Certification Form or similar certificate which will accompany the poultry during exhibition.
- 2) All non-certified birds must be banded (leg or wing band), with a sealed band. Wrap-around plastic bands are not acceptable. In-state waterfowl are exempt from pullorum-typhoid requirements.
- 3) Any poultry showing evidence of infectious or contagious disease or insect infestation will not be permitted to be exhibited.
- 4) Record Keeping – The sponsor of the exhibition shall compile a list of all poultry present at the exhibition. This list shall contain the name and address of each owner, the number, the species, breed, variety, type, sex, and pullorum-typhoid status of all poultry present. A copy of this list shall be retained by the sponsor of the exhibition for at least twelve (12) months.

OTHER IN-STATE TAME OR EXOTIC ANIMALS

JUNIOR EXHIBITORS

RULE 32. Entries in the Junior Division will be limited to exhibitors between the ages of 8 years old (as of Sept. 1, 2026 and in 3rd grade) and 19 at show time who are BONA FIDE members in good standing of an FFA Chapter or 4-H Club in the following counties in Arkansas: Benton, Conway, Crawford, Franklin, Johnson, Logan, Perry, Polk, Pope, Scott, Sebastian, Washington and Yell; and the following counties in Oklahoma: Adair, Cherokee, Delaware, Haskell, Latimer, LeFlore, McCurtain, McIntosh, Muskogee, Pittsburg, Sequoyah, and Wagoner. Junior exhibitors are not allowed to show at this Fair beyond the fall semester following graduation.

RULE 33. Premiums offered in the Junior Department are set up on a point basis. The value of those points will be the ratio of the total number of points won in all Junior Departments to the premium money offered. In addition to the premium money offered, prize money will also be offered for additional educational events. See respective Sections for premiums offered.

RULE 34. The following number is the maximum number of animals that will sell: 15 swine, 15 lambs, 15 steers, 9 pens of broilers, 2 pens of pullets, 4 goats, 4 pens of market rabbits. Auction facilities will be provided by Show Management to the exhibitors of market classes of livestock. Owners of market classes of exhibits must lead animals into the auction ring. Auction will be limited to junior exhibitors only. Sale order will be as determined by the judge. A junior exhibitor may sell only ONE animal in the auction, provided they have made the sale order selection. The only exception to the ONE animal limit is the Junior exhibitor who has animals in Grand or Reserve Grand standings of different species.

RULE 35. All county or school groups of five animals in the Junior Dairy Division must be owned by two or more exhibitors and limited to not more than one entry from each county or school.

RULE 36. No exhibitor in the Junior Division will be denied the opportunity to show their animal at this Fair as long as they have met all the requirements concerning ownership, entry, animal health, and other general rules that apply.

RULE 37. Check in/arrival time will be listed with each corresponding department. **NO ANIMALS WILL BE ALLOWED ON THE FAIRGROUNDS UNTIL 8 A.M. FRIDAY, September 25.**

JR. LIVESTOCK EXHIBITORS LOAD OUT:

RULE 38. You can load out equipment such as grooming chutes, boxes, etc. after conclusion of show.

If your animals are in Barns 1-2 or 3 you must enter the Fairgrounds through Gate 4 and exit through Gate 3. If you also have an animal in Barn 5 you may load it at the same time you are loading animals from Barns 1-2 or 3.

If you have Sheep in Barn 9 or Cattle in Barn 5 you must enter Gate 6 and exit Gate 4-A. No trailers will be allowed on the Fairgrounds until conclusion of your show. If you enter Gate 6 you must exit Gate 4-A. If you have cattle in Barns 1-2 or 3 you will have to exit Gate 4-A and re-enter Gate 4.

RULE 39. Animals in the Junior Division will show as indicated on the detailed show schedule provided in the catalog.

RULE 40. All Junior and Open Dairy must be in place by **7 P.M. Tuesday, September 29** and remain on exhibition until released by superintendent after conclusion of show.

RULE 41. No bulls will be shown in the Junior Beef class. Only registered heifers and registered ewes and rams will be allowed to show in the breeding animal classes.

RULE 42. The following entry fees will be charged in the Junior Division:

Beef.....	\$25 per head
Dairy.....	\$25 per head
Sheep.....	\$20 per head
Goats.	\$20 per head/\$25 (Dairy)
Swine.	\$20 per head

In order for animals to be shown in classes of a specific breed, the following minimum number of entries must be met:

- 10 for Breeding Beef breeds 5 in Junior Beef
- 10 for Dairy breeds
- 5 for Sheep breeds
- 5 for Swine breeds
- 5 for Market Steers

If these minimum numbers are not met by the entry deadline, the animals will be shown with all other registered breeds in similar age classes.

All Junior exhibitors **will be** allowed to enter their animals in the Open Division provided they meet all entry and fee requirements. No Junior exhibitor will be allowed to enter an animal in the Open Division **after** the entry deadline. Stalls may be reassigned for the Open Division.

Junior exhibitors with registered breeding stock must have the breed association registration certificate in their own name. **No transfer of papers will be allowed for registered animals. Therefore, ownership of the animal must take place in sufficient time for the registration to be completed.** All animals, unless otherwise specified, must be property of the exhibitor sixty days prior to the first day of the Fair. Heifers not having complete registration certificates may be entered in the commercial heifer classes.

LIABILITY OF EXHIBITORS

RULE 43. All property of every character entered for competition display, or for any other purpose, or brought onto the Fair Grounds by any person shall be subject to the rules and regulations prescribed by the Board of Trustees of the Arkansas-Oklahoma Regional Education and Promotion Association, Inc.

RULE 44. In no case shall the Arkansas-Oklahoma State Fair or any of its officers or directors, be held responsible for any loss, damage, injury or death by diseases, theft, or from any other cause of any character, to any property while same is on the Exposition Grounds, or any other time or place. The Management hereby assumes no responsibility, either as bailee or otherwise, for any property brought upon said grounds, all such property being brought and kept upon said grounds shall be at owner's risk.

RULE 45. If the property owners, or others interested in the property desire protection against loss, damage or injury from fire, or from any other cause, they must make their own arrangements and pay for such insurance.

RULE 46. Exhibitors making entries and not exhibiting shall forfeit all fees for stalls, pens or space or exhibitor's tickets.

CLAIMS FOR INJURY

RULE 47. No claim for injury to any person or property shall ever be asserted nor suit instituted or maintained against the Arkansas -Oklahoma State Fair, its officers or its

agent, by or on behalf of any person, firm or corporation or their agents, representatives, servants or employees having license or privilege to exhibit on said Exposition Grounds, or occupying space thereon, the Arkansas-Oklahoma State Fair shall in no manner be responsible therefor, and in case it be subjected to any expense or liability all persons causing same or liable therefor shall indemnify the said Arkansas-Oklahoma State Fair.

RULE 48. The Arkansas-Oklahoma State Fair will not be in any way liable for injury to any attendant of any exhibit in all departments while enroute to or from the Fair.

CONCESSIONS AND PRIVILEGES

RULE 49. SECTION 1. Parties desiring to apply for concession space can do so at any time on application to Concessions Manager, Arkansas-Oklahoma State Fair, P.O. Box 4145, Fort Smith, Arkansas 72914.

SECTION 2. The Board of Trustees and Superintendent of Concessions will use every precaution to guard against extortion in any form practiced upon the patrons of the Fair. A violation of this rule by the concessionaire will cause the forfeiting of contract, money paid or expulsion from the grounds as the management or Superintendent may direct.

RULE 50. DEFAULT WITH OTHER FAIRS – The Arkansas-Oklahoma Regional Education and Promotion Association, Inc. reserves the right to cancel any contract upon receipt of notice from any Fair holding membership in the International Association of Fair and Expositions, that the exhibitor or concessionaire has been suspended or expelled from or for violation of contract or rules of said member.

MEMBERSHIP

RULE 51. The Arkansas-Oklahoma State Fair is a member of the International Association of Fairs and Expositions. The rules of the above named associations will govern all events at the 2026 Arkansas-Oklahoma State Fair, and their rules shall become a part of all contracts entered by the Arkansas-Oklahoma Regional Education and Promotion Association, Inc.

PARKING

RULE 52. ALL EXHIBITORS will be issued an Exhibitors Card that will admit them to the Fairgrounds until the expiration date on the card. They will also receive a colored Parking Pass that will allow them to park in the parking lot designated on the pass. The exhibitor cards and parking passes will be issued by the Superintendents upon check in.

Due to the lack of space, and the time that you arrive, a parking pass will not guarantee you a parking place in the parking lot that your pass is for. People who pay for a Camper Hook up will be issued a parking pass for their two vehicles.

Traffic flow through the Fairgrounds must be possible at all times for emergency vehicles. Any vehicle which blocks other vehicles in or is parked in a marked tow away zone, or is blocking a street will be towed immediately, at the owner's expense, and their parking pass confiscated for the duration of the Fair.

RULE 53. JR. LIVESTOCK EXHIBITORS will be allowed to enter the Fairgrounds to unload their livestock and equipment, then they must exit immediately after unloading and parking their trailers. Vehicles will not be allowed back on the Fairgrounds until

SATURDAY morning to bring in feed and needed supplies, and they must be off the Fairgrounds by 9:00 AM. Any vehicle on the Fairgrounds after 9:00 AM without the proper parking pass on the windshield will be towed at the owner's expense. Parking Passes are for off ground parking lots. LOAD OUT INSTRUCTIONS are on rule #62 and rule #45-A, in the Fair Catalog.

CAMPERS & ETC. – Each unit paying for an electric hook up for living quarters will be issued a pass for another vehicle to be parked on the Fairgrounds.

INELIGIBILITY OF JUDGES

RULE 54. Official judges of the Arkansas-Oklahoma State Fair are ineligible to receive premium money as an exhibitor. Exhibits of judges may be for display only.

OPEN LIVESTOCK LOAD OUT

RULE 55. Your Exhibitors Pass is all that you will need to get in the Fairgrounds for this. Trailers will not be allowed until the release time, based on department, double check with your superintendents.

EMERGENCY MEDICAL SERVICES

An emergency medical facility staffed by medical personnel is located under the north end of Harper Stadium.

CAMPING

A limited number of camper hookups are available on a first come basis at a charge of \$35.00 per day. No camping trailers, or camping, is allowed except in designated areas on Fairgrounds. Campers are allowed to have 12 feet of space per camping trailer. Vehicles which are parked in designated camping spaces will be charged the daily camping rate whether they are using the utilities or not.

1. No open dairy will be allowed to enter the fairgrounds before 8:00 A.M. Tuesday, September 29. All open dairy must be in place in stalls assigned by the superintendent by 5:00 P.M. and remain in exhibition until released by superintendent after conclusion of show Thursday, October 1. All open dairy must enter Gate 6 on Plum Street during official check-in hours.
2. Registration papers and proof of ownership, with Bang's certificate or calfhood vaccination, must be shown to appropriate individual at the entry gate. **NOTE: No pending registration papers will be accepted on animals born before Jan. 2026.**
3. Only first place winners in single classes in open competition and Junior Division may compete for champion and only champion winners may compete for grand champion.
4. All stalls must be cleaned before 9:00 A.M. each day and the refuse disposed of as Superintendent may direct. Straw bedding will be allowed.
5. Cows in milk must be milked completely and thoroughly after 6:00 P.M. on the day before the cattle are to be judged.
6. Artificial means of removing or remedying physical defects of conformation in exhibition animals, such as lifting or filling under the skin, will be considered fraud and deception. All animals giving evidence of such treatment will be barred from exhibition at the Fair, and at all Fairs holding membership in the International Association of Fairs and Expositions.
- 7. Not over two premiums will be awarded in any individual class to any one exhibitor.**
8. Markings or tattoo numbers must match registration papers.
9. All cattle shall be entered in class shown on initial entry form, i.e., cattle cannot be changed from open to junior division or visa-versa. Only cattle entered may be shown.
10. Two-year-old heifers **may** be shown **before** freshening.
11. Animals entered and exhibited in the division must all be from one single herd, running together and operating at one location as a unit owned by an individual, or by a corporation, or by a partnership, or by a working family unit. Cattle must be entered and shown as one

herd. (Farm name is recommended.)

12. Yearling heifers in milk must be shown in two-year-old heifer class.

1. All Breeds with less than 5 head shown will receive 50 percent of listed premium.
2. JUNIOR EXHIBITORS WILL BE ALLOWED TO SHOW IN THE OPEN DIVISION WITH THE SAME ANIMAL.
3. All Open Beef will need to be check-in between 1:00 and 6:00 P.M. on Monday, September 28 **Judging - Tuesday, September 29 at 3:00 P.M.** Animals will be released 1 hour after show.
4. All Open Beef will enter Gate 4 on Waldron Road and exit Gate 3 on Midland Blvd. Animals will be allowed on fairgrounds during official check-in hours only.
5. Registration papers or eligibility to register, and proof of ownership, with Bang's certificate or calthood vaccination certificate, must be shown to Superintendent before animals can be placed in stalls. **NOTE: No pending registration papers will be accepted on animals born before Jan. 1, 2026.**
6. Where there is no competition for exhibitors, or where only one exhibit is entered, **see Rule No. 21.**
7. All stalls must be cleaned before 8:00 A.M. each day and refuse disposed of as superintendent may direct.
8. All juniors who wish to show in the Open Division will be allowed to keep same stalls with Superintendent approval, otherwise, exhibitors should remove their animals and tack so that preparation for the Open Beef competition can be completed.
9. Any artificial means of removing or remedying physical defects of conformation in exhibition animals, such as lifting or filling under the skin, will be considered fraud and deception. All animals giving evidence of such treatment will be barred from exhibition at the Fair, and at all Fairs holding membership in the International Association of Fairs and Expositions.
10. Individual animals shown in all groups and herd classes must have been entered and shown in one of the classes for single animals.
11. No exhibitor will be allowed to show more than one entry for herds or groups except in "Get of Sire" and "Produce of Dam" and then only when entries are by different sires and out of different dams.
12. No exhibitor shall be permitted to win more than two premiums in any one class.
13. Breeds must meet the requirements of their respective association to be eligible to show.
14. Supreme heifer and bull will be chosen at the conclusion of all the breed shows. Grand

Champion from each breed will be eligible to compete. Prizes will be given.

15. Any individual breed awards can be distributed during the show but must be provided by outside parties.
16. Changes to show can be made by fair management if the need arises regardless of what is printed in the book, and all decisions by management are final.

SECTION A – ABERDEEN ANGUS

Any animal not having a legible tattoo is ineligible to compete and will be barred from showing.

Exhibitors must have the original registration certificate on each animal available for inspection at the show.

The exhibitor is responsible for furnishing the Superintendent the names of animals shown in groups, and herds, and championships.

All animals must be from a registered sire and dam.

All animals must be registered in the herd book of the American Angus Association. The registration certificate issue date must be prior to the show date.

The skin color of all animals must be BLACK, except those animals having birth marks or white hairs on black skin. Animals red in color, or with white skin above the underline, in front of the navel or on a leg or foot, are not eligible to show.

All animals must be polled (free of horns or scurs). Scurs are defined as any portion of horny tissue attached to the skin of the horn set of a polled animal. Any product administered internally or used externally to alter the conformation and/or appearance of an animal for exhibition is prohibited. This includes the covering

of white skin, false tail heads (or use of any false hair), use of graphite, powders, hemp or other similar substances externally and steroids, growth stimulants or artificial filling internally. Any animal found to be

in violation will be barred from showing. The exhibition of cattle displaying false hair will not be allowed, with the exception of false tail switches. Exhibitors must have the original registration certificate on each animal available for inspection at the show. All animals must have a legible permanent identification mark that can be ear tattoo marks, freeze-branded marks or hot-branded marks. The permanent identification mark must correspond with the permanent identification mark as indicated on the official registration certificate. Once disqualified due to an incorrect or illegible permanent identification mark, animals cannot be re-marked and rechecked at the show.

All animals must be shown within the official standard show classification of the American Angus Association. Only one person at a time shall lead animals into the show ring.

Exhibitors who participate in shows that accept premium monies contributed by the American Angus Association are subject to the Association Rules as found in the Breeders Reference Guide of the Association. These rules are found in Part 2; Association Rules. The rules relating directly with the exhibition of Angus cattle are Part 2: Association Rules; Rule 800 Series; including Rule 800-811. These rules can be found at www.angus.org.

Any female shown with calf at side, the calf must be her natural calf and registered.

At any show for which the American Angus Association appropriated funds toward the payment of premiums, no exhibitors, individuals assisting exhibitors or member owners at such show shall be

allowed to use any coloring agents, on any animal exhibited. The Association may adopt and implement various tests designed to monitor this prohibition, including but not limited to a “white towel” or “white glove” test. No aerosol cans or other pressurized containers will be allowed in designated make up areas.

All animals exhibited are subject to DNA markers or blood type test to verify accuracy of parentage as covered under the Association Rules and for other testing as required by the individual show.

Authorized representatives of the Association have the authority to enforce the rules set forth herein as well as in the Association Rules, including the barring of a registered animal from a livestock show at which it is to be shown, if there are reasonable grounds to believe a violation has occurred.

All animals must have been shown in their respective single-entry classes, and they must be owned by exhibitor or by a member of his/her immediate family. A cow/calf will be considered as two head in the Best Six Head Class.

SECTION C – LIMOUSIN

All animals must be registered with the North American Limousin Foundation. Any animal over 30 days of age, including calves to be shown at side of dam, must have proof of a registration certificate and be recorded with the North American Limousin Foundation. For ET calves, parentage verification paperwork must be in the NALF system.

All animals must be 75% (3/4) Limousin or greater as indicated by registration certificate. Percentage and purebred Limousin cattle shall compete in the same classes and championships (amended 8/98).

All animals must be properly tattooed and will be inspected at the show. Tattoos must be legible and must properly match the registration certificate. If an animal's tattoo is not legible and cannot be read the first time through processing, it will not be allowed to come back through with a fresh tattoo.

Fresh tattoos are acceptable but animals that do not have legible tattoos when first processed will not be reprocessed, any animal not having a legible tattoo will not be allowed to participate in the show.

To maintain a high degree of confidence in Limousin shows, the North American Limousin Foundation reserves the right to disqualify any animal that has been fitted in an unethical manner. Unethical fitting shall include the following:

Fresh tattoos are acceptable but animals that do not have legible tattoos when first processed will not be reprocessed, any animal not having a legible tattoo will not be allowed to participate in the show.

To maintain a high degree of confidence in Limousin shows, the North American Limousin Foundation reserves the right to disqualify any animal that has been fitted in an unethical manner. Unethical fitting shall include the following:

- a) any use of paints, hair coloring conditioners, colored show foam, graphite, colored powders or any other substances; all animals subject to white towel test (amended 8/01);
- b) The addition of any hair or hair like substances, including false tailheads and false polls (false tail switches are allowed);
- c) The cutting, tearing or gluing of the hide or underneath the hide or removal of tissue in an attempt to alter the shape of the animal;
- d) The injection of any gas, solid or liquid under the hide to alter the normal conformation;
- e) Any products/solutions/liquids administered internally or externally to alter the conformation of the animal is prohibited. This includes the use of steroids, growth promotants, and the act of artificially filling animals internally, which would include stomach pumping, drench tubes, or any other method.

EXCEPTIONS: In the case of severely sick or severely dehydrated animals, the exhibitor may have fluids or electrolytes administered by the licensed official show veterinarian with the approval of the show superintendent and/or North American Limousin Foundation representative. This exception is not applicable on show day or weigh-in/check-in day.

All bulls over one year of age must show with a nose-lead. The right to disqualify from the show any animal deemed unmanageable is reserved by the Limousin show superintendent and the show.

All protests against exhibitors, individual animal or **fitting violations** of show cattle must be submitted in writing and signed by five (5) lifetime members of the North American Limousin Foundation and presented to the show superintendent within 12 hours after the completion of the show.

The North American Limousin Foundation reserves the right to mouth animals for dental development at any show sponsored by the Foundation. Classes and championship breaks will be made-up after all cattle have been checked in. No class shall contain more than 20 head or have an age spread of more than 60 days unless the animals are over two years old. Premiums will be awarded on a graduated basis among the animals in the classes after the show has been completed.

Calves exhibited alongside dams in the cow/calf division are ineligible to show as individuals. In addition, all calves exhibited alongside dams must be registered. (January 2000 amendment)

All cattle will be processed before the show.

In shows occurring after January 1, 2025; animals born through June 30, 2022 are eligible to show.

The North American Limousin Foundation reserves the right to collect hair samples from any animal, at any show.

All animals shown must be solid red or black above the flanks, except birth marks. (amended 1/03).

At the conclusion of the Junior Heifer show, the Judge will select a Supreme Champion Junior Heifer and Reserve Supreme Champion Junior Heifer. Only Breed Champions will be eligible for the Champion award. The reserve breed champion may enter the ring if the Supreme Champion was selected from that breed. *AOB and American Breeds Champions will be eligible for Supreme Champion honors.

All junior beef should enter Fairgrounds using Gate 4 on Waldron Road during official check-in hours only. Blocking chutes will not be allowed in barns, unless designated by superintendent, in the interest of the safety of the animals, exhibitors, and the public.

SPECIAL RULES

Exhibitors in all breeds are subject to the show guidelines of their respective breeds. Entries are accepted with the understanding that the exhibitor agrees to abide by the rule in all respects.

ENTRIES WITH OUT PICTURES WILL BE DISQUALIFIED!

PHOTOS NEEDED ARE: One picture of the number in the ear, and another front view picture of the exhibitor and animal.

Example, the photo should show the tattoo or 840 tag in the animal's ear. All letters and numbers must be identifiable in the photos.

NO Doctored photos allowed. Any photos with any suspicion of being doctored will result in the animal being disqualified.

Your County Agent or Agriculture Educator must inspect the tattoo or 840 tag then submit your entry form.

The 840 tag eliminates the need to catch the head of the steer and saves time.

The inability of the 840 tags to be read but the tag reader will be considered tampering and therefore disqualifications, if your tag does not read, you will be disqualified!

The only other ear tag allowed are: OYE, AYE, Arkansas State Fair, Tulsa Fair, Etc. all other tags are Prohibited. NO Name, Number, or herd tags are allowed. Prohibited tags should be removed BEFORE

Check-In time, failure to do so will result in disqualification.

TACK / STALL ASSIGNMENT:

You can bring your tack on Thursday, September 24, from 5:00 to 8:00 p.m. Please check for stall assignment form at the Livestock Office before placing tack.

CHECK IN/ FRIDAY 25TH:

- Steers may enter fairgrounds from 8 am to 7 pm.
- Check in your steer from 4 pm to 7 pm. NO EARLY ARRIVALS.
- You will be given two exhibitors cards at CHECK IN, bring both WEIGH IN on Saturday.

CLASSIFICATION / SATURDAY SEPTEMBER 26TH WEIGH IN:

- The steer classification will be from 10 am to 12 pm.
- Each exhibitor must bring both exhibitor cards to weigh in.
- During the classification, the exhibitor will be allowed in the classification area.
- Steers for the Market competition must weigh 1000 lbs. or above. Steers less than 1000 lbs. are eligible for the Prospect competition. NO EXCEPTIONS!

ARTIFICIAL PRACTICES – DISQUALIFICATIONS

THE ARKANSAS-OKLAHOMA STATE FAIR RESERVES THE RIGHT TO COLLECT URINE OR BLOOD SAMPLES FROM ANY STEER FOR LABORATORY ANALYSIS.

AN EXHIBITOR OF A STEER PRODUCING A SAMPLE HAVING A QUANTITY OF DIURETIC OR UNAPPROVED MEDICATION OF ANY KIND WILL FORFEIT ALL RIGHTS AND PRIVILEGES TO EXHIBIT LIVESTOCK IN THE FUTURE AT THE ARKANSAS - OKLAHOMA STATE FAIR.

Management has the right to disqualify any animal. If the appearance of any animal has been materially changed or altered by any process. This includes attempts to dye or color which alters their natural coloration.

Any entry adding an artificial tail head, tail head, tail fin, artificial poll, or adding any hairlike substance will be disqualified.

UNETHICAL FITTING:

The giving of an oral injection diuretic, or a growth stimulant not approved for market steers, or any pre-show injection of any compound that may cause a quantitative or qualitative change in the characteristics of the animal on foot or in carcass constitutes unethical fitting and will result in disqualification. No premiums will be paid to the exhibitor.

In the Market Animal Auction, all sale money will be withheld after slaughter if the animal is found to have been tampered with, altered, or if the carcass is condemned.

Health & Identification Requirements

- **SWINE WILL BE REQUIRED TO HAVE THE PSEUDORABIES TAG.**
- According to Arkansas State Regulations, all swine exhibited at the AR/OK State Fair will have to have an official 840 tag issued by a state agency.
- Ear notch and 840 tag must match entry.

Official Rules

1. All official 840 tag numbers and ear notches must match the entry documentation. While this has always been a standard requirement, strict compliance will be actively verified and enforced during the 2026 check-in process, and during the show. Furthermore, any animal arriving at the fairgrounds with a missing official 840 tag will be deemed ineligible for entry and show. Mismatched or missing tags cannot be corrected after arrival, and any discrepancies may result in immediate disqualification.
2. No Market Swine will be allowed to enter the fairgrounds before 9:00 A.M. Friday, September 25. All Market Swine must be in place in pens assigned by the superintendent by

7:00 P.M. Friday, September 25 and remain on exhibition until 2:00 P.M. Sunday, September 27, except sale order animals.

3. Each exhibitor shall be responsible for keeping pens and alleys in a clean condition. All pens and alleys shall be thoroughly cleaned each morning. **NO watering systems in the pens!**
4. All market swine must weigh between 200 and 290 pounds to show.
5. Swine will be shown by breed (as listed above) and weight. Classes will be determined after all entries are in. No minimum to make a Breed.
6. **THERE WILL BE AN OFFICIAL WEIGH-IN.** Exhibitors will bring animals to superintendents to weigh in time between 5 P.M. - 8 P.M. Friday, September 25. Show classes for each breed will then be determined. Classes will be kept as uniform in size as possible and will be posted. Final breed classifications will be determined at weigh-in by a committee chosen by the superintendent. All decisions by the committee will be final.
7. Each exhibitor may bring only two swine in the show but may enter as many as they wish.
8. All swine must be owned by exhibitor sixty days prior to show.
9. Barrows and Gilts may show in the Market Swine show.
10. Any hog shown in the wrong class will be disqualified.
11. Pens will be assigned by the swine superintendent.
12. Two cards turned in on the same animal will result in disqualification.
13. Exhibitors may not reserve or "hold" pens for later arriving exhibitors or pigs. Exhibitors wishing to pen together must arrive together. However, due to limited space, pigs will be penned at the discretion of the swine/barn superintendent.
14. Exhibitors are allowed to bring tack in early. However, pen assignments will not be made until pigs arrive on the fairgrounds. Tack will be placed in a designated area until the pigs arrive. No tack allowed in pens. All Exhibitors must have appropriate bedding for their pigs.
15. Due to limited pen space, 2-3 pigs will be assigned to each pen. Individuals should bring panels to separate their pigs (4' x 8' pens).
16. The swine superintendent will distribute entry cards after the pigs have been placed in an assigned pen. **EXHIBITORS WILL NOT RECEIVE AN ENTRY CARD UNTIL THEIR PIG IS IN THEIR ASSIGNED PEN.**
17. Exhibitors who have not returned a completed entry card by 8:00 p.m., Fri., Sept. 25th, will be required to remove their animal from the fairgrounds.
18. Any exhibitor, chapter or club dismantling or changing the shape of a 4' x 8' pen will cause the disqualification of the entire group.
19. No one besides exhibitors are allowed in holding pen or placement.
20. All questions in dispute or difference not covered by these rules will be referred to show management, whose decision shall be final.
21. Show Management and the Swine Superintendent reserves the final and absolute right to interpret these rules and regulations, and to arbitrarily settle and determine all matters, questions, and differences in regard thereto. Management further reserves the right to amend or add to these rules at any time as they deem necessary for the benefit of the show.

Substitute Showman Policy:

Substitutions will only be allowed for the following reasons:

- A. An exhibitor has two animals in the same class.
- B. Conflicts with animals being exhibited at the same time in other species at the Arkansas Oklahoma State Fair.

- C. Sickness or a physical injury documented by a physician.

Steps to Obtaining a Substitute Showman

If an exhibitor qualifies under one of the circumstances above, they must identify a substitute showman using the following priority order:

- **a. Immediate Family Member:** If an immediate family member is not present and eligible, then the exhibitor proceeds to step (b).
- **b. An exhibitor from the exact same FFA Chapter or 4-H Club:** If a member of the exhibitor's FFA Chapter or 4-H Club is not present and eligible, then the exhibitor proceeds to step (c).
- **c. An exhibitor from the exact same county in which the exhibitor resides:** If an exhibitor from the exact same county in which the exhibitor resides is not present and eligible, then the exhibitor proceeds to step (d).
- **d. Finally, an eligible exhibitor exhibiting at the Arkansas Oklahoma State Fair.**

Compliance Requirements

- **For Reasons B and C:** All superintendents must be notified of the possibility of a substitute showman by the conclusion of check-in.
- **For Reason A:** If an exhibitor ends up with two animals in the same class, swine show management must be notified immediately at that time.

Important: Failure to follow the stated procedures or comply with these notification deadlines may result in the animal and the exhibitor being disqualified from the show.

Show Schedule:

- **JUDGING WILL BEGIN SUNDAY, SEPTEMBER 21 AT 9:00 A.M. IN SHOW BARN - B**
- All Junior animals and equipment must be out of the barn by 9:00 P.M. Sunday, September 21.

Market Barrow Characteristic Guidelines:

A committee chosen by the swine superintendent will ensure breed characteristics at weigh in.

The decision of the classifying committee and Superintendent is final and not subject to protest.

Berkshire Breed Character Guidelines

1. A black and white animal with erect ears, exhibiting Berkshire characteristics.
2. A Berkshire must have white on all four legs, face and tail (unless tail is docked). One of the white leg points may also be missing.
3. Must be ear notched within seven days of birth.
4. A Berkshire must NOT have a solid white or a solid black face from the ears forward.
5. A Berkshire must NOT have a solid black nose (rim of nose).
6. White is allowed on the ears, but NO solid white may appear on the ears.
7. Occasional splash of white may appear on the body.

Chester White Character Guidelines

1. Must possess Chester White breed characteristics.
2. Must be ear notched within seven days of birth.
3. Must be solid white in color, no color on the skin larger than a silver dollar, no colored hair.
4. Ears must be down and medium-sized.

5. Any size of weighted ear tags or evidence of past existence of such ear tags are determined to be not permissible and are grounds for disqualification.
6. Any skin pigmentation, other than white, that exceeds five in number will disqualify the barrow.

Duroc Breed Character Guidelines

1. Must be red in color and possess Duroc Characteristics.
2. Ears must be down and medium-sized.
3. Must be ear notched within seven days of birth.
4. Must NOT have any white hair located on the animal.
5. Must NOT have any black hair.
6. Must NOT have more than three black spots on the skin and none of these spots can be larger than two inches in diameter.
7. Must NOT have any shading or indication of a belt.

Hampshire Breed Character Guidelines

1. Must be black in color with a white belt starting on the front leg. The belt may partially or totally encircle the body. Must have a white belt across the shoulders, covering both front legs around the body, making a continuous belt.
2. White may not go past the sheath or navel.
3. White may not go above the hock.
4. Must possess Hampshire breed characteristics: ears must be erect and not rounded.
5. Must be ear notched within seven days of birth.
6. Must NOT have any white hair or indications of streaking on the forehead.
7. Must NOT have any red hair.

Hereford Breed Character Guidelines

1. Must be red, light, or dark with at least 50% white face, at least 50% red body, and at least 3 white feet.
2. Must be ear notched within seven days of birth.
3. Ears must be at least broke forward.

Landrace Breed Character Guidelines

1. Must be white in color and possess Landrace breed character. Ears must be down.
2. Must be ear notched within seven days of birth.
3. Must NOT have any colored hair except white.
4. Must NOT have more than three spots of pigmentation.
5. Must NOT allow any spot of skin pigmentations larger than one U.S. minted quarter.
6. Must have no evidence of an extra dewclaw.

Poland China Breed Character Guidelines

1. Must possess Poland China Breed Characteristics.
2. Must be ear notched within seven days of birth.
3. Must be black with six white points (face, feet and switch) with an occasional splash of white on the body. A hog may not possess more than one (1) solid black leg and be determined as a Poland China. (Tail docking is permissible).
4. Must have ears down.
5. Must NOT have any evidence of belt formation of either white or white encircling and touching the points of the shoulder extending down on both sides of animal to the depth of the elbow pocket.
6. Cannot have any red or sandy hair and/or pigment.

7. Hogs that have weighted ear tags or evidence of such tampering are ineligible.

Spotted Swine Breed Character Guidelines

1. Must be black and white in color.
2. Must possess Spotted Breed Characteristics.
3. Must be ear notched within seven days of birth.
4. Ears must be down and reasonable sized. Ears cannot be erect.
5. Any red tinted or sandy brown spots are ineligible.
6. No solid black head from ears forward.
7. No distinct white belt pattern (hair or skin) encircling and extending down and onto each shoulder.
8. Purebred, non-appendixed pedigrees only are accepted.

Tamworth Breed Character Guidelines

1. The general color of Tamworth shall be red. No animal may show as a Tamworth that has more than twenty black spots of hair, or any one spot of black hair larger than four inches in any direction.
2. Must be ear notched within seven days of birth.
3. Any animal with white appearing anywhere on the body, except the hooves, shall not be eligible to show.
4. Ears are pointed, and upright.

a. Below deviations from Tamworth type may disqualify the hog:

Shadow of a belt across the back; Head which differs from Tamworth type, such as a head typical of a Duroc or other breed with an upturned snout; General build, bulk, animal whose ears are dropped or floppy. or stature atypical of the breed as historically known.

Yorkshire Breed Character Guidelines

1. Must be white in color and possess Yorkshire breed characteristics: Ears must be erect.
2. Must be ear notched within seven days of birth.
3. Must NOT have any colored hair other than white.
4. Must NOT have more than two pigmentation spots larger than a U.S. minted dime or one pigmentation spot larger than a U.S. minted quarter. These pigmentation spots (combined) can NOT exceed a U.S. minted silver dollar.

Light Cross Breed Character Guidelines

1. Any hog with white and/or blue only.
2. All other colors, (black, red, and sandy), excluding solid white or blue.
3. Must be ear notched within seven days of birth.

Crossbred Guidelines Breed Character Guidelines

1. Any market hog that does not satisfy the requirements of one of the above stated breeds will only have the option to be in the crossbred breed divisions.
 2. Exhibitors may elect to have their animal placed in the Dark cross division.
 3. Must be ear notched within seven days of birth.
- All Swine must enter Gate 6 on Plum Street during official check in hours only.

**RULES FOR THE
ARKANSAS BRED LAMB SHOW
TO BE HELD AT THE ARKANSAS STATE FAIR
AND DISTRICT FAIRS**

It is the intent of the Arkansas State Sheep Council to utilize this program, to teach animal stewardship to Arkansas Youth, to improve genetics and quality of Arkansas Sheep and to promote the continued growth of the Sheep Industry in Arkansas.

NOMINATION PROCEDURE AND REQUIREMENTS

1. For a lamb to be nominated to show as an Arkansas Bred Lamb, the lamb must be bred by and/or purchased from and nominated by an association member in good standing.
2. The exhibitor must be a paid member of the Arkansas Junior Sheep Council.
3. The exhibitor must register the ABL lamb to be shown through the Arkansas Junior Sheep Council by July 31, 2026.

RULES

4. All rules pertaining to the Arkansas-Oklahoma State Fair Junior Market Lamb Show will be in effect for the ABLS, except as defined in section 1 of this rule guide.
5. A separate weigh-in card will be required for the Arkansas Bred Lamb Show and exhibitor shall designate on this card that the Lamb is to be shown as Arkansas Bred. Exhibitor will list both Scrapie and ABL tag numbers on weigh card.
6. Exhibitors shall put Arkansas Bred Lamb ear tags numbers on the weigh-in card. **Note: a maximum of 3 lambs can be shown in the ABL show.**
7. The official ear tag shall be in place at the time of the show. The name on the nomination form **MUST** match the name of the exhibitor to be eligible for the show.
8. First, second, and third place class winners shall be nose printed after the class placing or the Championship show and the nose print must match the ASSC file print for premiums to be paid.
9. **THE ARKANSAS STATE SHEEP COUNCIL, ARKANSAS STATE FAIR AND CORPORATE SPONSORS** will provide awards and prizes for the Arkansas Bred Lamb Show.

SPECIAL NOTE:

The Junior Livestock Auction will be held at 6:00 P.M., **Monday evening, September 28**, in the Harper Stadium.

1. Only market animals for the steer, swine, lamb, goats, broiler, pullet and rabbit classes are eligible for this sale. [ONLY LIVESTOCK WILL SELL. WILL NOT SELL DECORATIONS OR ACCESSORIES]
2. A Junior exhibitor may sell only one animal in the auction, provided they have made the sale order selection. The only exception to the ONE animal limit is the Junior exhibitor who has animals in Grand or Reserve Grand standings of different species.
3. Only the top two positions in each animal sale order are automatic. All other positions in the sale order are selected at the discretion of the judge.
4. **All Grand and Reserve Champion animals will be sold in the Jr. Livestock Auction – steers, lambs, goats, swine, broilers, pullets, and rabbits.**
5. All animals in the auction will be permanently identified when they are selected for sale order.
6. The following number is the maximum number of animals that will sell: 15 swine, 15 lambs, 15 steers, 9 pens of broilers, 2 pens of pullets, 4 goats, 4 pens of market rabbits
7. All animals entered in the Junior Auction must be shown by the junior owner, unless prior arrangements are made with the appropriate superintendent. Exhibitors must comply with sixty-day ownership rule. (See GENERAL RULES, RULE 8.)

JR.
